New Jersey National Guard Tuition Waiver Program Information Sheet



Eligibility Criteria:

Individuals serving in the New Jersey National Guard (Army or Air) who believe they are eligible for the tuition waiver program must:

- *Have completed Initial Active Duty Training.*
- *Currently be in good standing with their unit.*

Additional Criteria:

In addition to the basic eligibility criteria, a qualified member will also meet the following criteria:

- ***Must have applied for financial aid (FAFSA) in the current cycle***
- *Must produce a computer generated NJDMAVA Form 621-2-R "Commander's Certification" every semester with a valid control number and commanders signature affixed*
- *Must maintain the current academic standards set by the school*

To utilize a New Jersey National Guard Tuition Waiver for coursework pursued at Middlesex County College, please follow the procedure below:

- 1. Meet the basic eligibility criteria listed above.*
- 2. Use the attached resources to submit a FAFSA application if not done already.*
- 3. Have the Middlesex County College Financial Aid Department fill out their portion of the attached "College Verification Form".*
- 4. Return the form to the Center for Veterans Services along with a correctly administered NJDMAVA Form 621-2-R for processing*.*

* You are required to use available financial aid before the National Guard Tuition Waiver will be applied to your account. Understand that if you are eligible to use the National Guard Tuition Waiver you will not pay for your tuition out of pocket (up to 15 credits). Your tuition will be covered by financial aid, the waiver, or a combination of both.
